

Please make the following changes in your Code and Digest. Mark these changes "2008" to indicate the year in which it was passed. Your assistance will help Grand Chapter save money.

Page 9

ARTICLE IX, VOTING AND PROXIES In the title, delete the words "AND PROXIES". This change will apply only to those members who have the first edition of the Code and Digest when the size changed to 8½" x 11".

Page 9

ARTICLE X, VACANCIES, Section 2 delete the words in the first line "an appropriate" and add an 's' to member. Insert the words "or financial review" and the end of the paragraph after the word "audit". The Section would then read, "The Worthy Grand Matron shall appoint members to fill all other vacancies occurring in the elective Grand Officers, Board of Trustees and Benevolent Board. The Past Grand Matron and/or Past Grand Patron accepting the office of Grand Secretary or Grand Treasurer shall be duly installed and assume the position with benefit of an audit or financial review."

ARTICLE VII, POWERS AND DUTIES – GRAND OFFICERS, Section 6, 9(b) change reference to By-Laws and Rules, Article V, Section 16 to Section 15.

ARTICLE X, GRAND CHAPTER COMMITTEES, Section G, 2 change reference to By-Laws and Rules, Article V, Sections 13 and 14.

Page 33

ARTICLE XII, ANNUAL PROCEEDINGS, Section 4 add: F. Two (2) copies to General Grand Chapter.

Page 34

ARTICLE XIII, MEMBERSHIP ROSTER, Section 2 add "Chairman of the Registration Committee" to the distribution list. Would then read, "One (1) complimentary copy shall be provided to each Idaho Subordinate Chapter, each Idaho Grand Chapter elective officer, each Past Grand Matron or Past Grand Patron serving on the Jurisprudence Committee, the Chairman of the Benevolent Board and the Chairman of the Registration Committee. The Roster shall not be used for commercial purposes."

ARTICLE VI, POWERS AND DUTIES OF OFFICERS – GRAND OFFICERS, Section 6, B, 1 delete "with a permanent locking device, but must be purchased from the Grand Secretary". Would then read: "Minutes may be recorded in a loose-leaf book."

ARTICLE VI, POWERS AND DUTIES OF OFFICERS – GRAND OFFICERS, Section 6, J delete "separate checks for". Second sentence would then read "Indicate fifty year, dual and voluntary prepaid life members and include the per capita tax and International Headquarters Fund monies."

ARTICLE IV, INSTRUCTIONS FOR OFFICERS, Section 12 third line: "The Warder must not interrupt business be advising the" change the "be" to "by"

ARTICLE XXII, INITIATION, Section 13 last two lines read, "The Conductress communicates the Grip of the Order to each new member. If there is more than one new member she passes back of them to her position." Change to read, "The Conductress communicates the Grip of the Order to each new member, passing back of new member(s) to return to her position."
