ARTICLE II ANNUAL SESSIONS, Section 1 remove the words "and Valley #74"

### Page 17

ARTICLE VII POWERS AND DUTIES – GRAND OFFICERS. Section 2 Worthy Grand Matron, B, 11, 3<sup>rd</sup> sentence: add the word "Grand" before Jurisdiction. Would then read: "...forms for Waiver of Grand Jurisdiction, ..."

ARTICLE VIII, POWERS AND DUTIES – BOARDS, Section 1, K, 4, a: Delete the words at the end of the paragraph: "and not more than one hundred thousand dollars (\$100,000) in one account." To be grammatically correct, the word "fiduciary" should be changed to "fiduciarly".

ARTICLE X GRAND CHAPTER COMMITTEES, Section 2I Jurisprudence, paragraph 2, within parentheses "(except Special Appointments as listed in Section 5, page 55)" Add "Article X" before the words "Section 5" and delete "page 55".
